(1) On April 20, 2012, the Company granted Mr. Houghton an option to purchase 675,000 shares of common stock of the Company (the "Option"), under the Company's 2004 Stock Incentive Plan, in connection with his appointment as the President and Chief Executive Officer of the Company. The Option vests in equal monthly installments over four years commencing on the date of initial grant; provided that Mr. Houghton remains employed by the Company at such time.
