This estimate is made pursuant to Rule 457(c) solely for purposes of calculating the registration fee pursuant to (2)Rule 457(h), and is based on a price of \$16.62, which represents the average of the high and low prices per share of Common Stock as reported on the New York Stock Exchange on August 7, 2013.

Employee Stock Purchase Plan (as amended, the “Plan”). Under this registration statement, the Company is registering an additional 150,000 shares of Common Stock reserved for issuance from time to time in connection with the Plan.
