**Item 2.02 Results of Operations and Financial Condition**

On October 28, 2008, G&K Services, Inc. issued a press release announcing its financial results for the fiscal first quarter ended September 27, 2008. A copy of the press release is furnished as Exhibit 99.1 to this report. The press release contains non-GAAP financial measures which are the organic industrial rental growth rate and free cash flow. The organic growth rate is calculated using industrial rental revenues, adjusted for foreign currency exchange rate differences and revenues from newly acquired locations. Management believes that by eliminating the impact of the U.S.-Canadian exchange rate and the effects of the company's recent business acquisitions, the organic growth rates better reflect the growth of the company's existing industrial rental business. The free cash flow result is calculated as cash flow from operations less capital expenditures. Management believes that organic growth and free cash flow are useful in analyzing the company's overall financial condition and the results of its operations.
