



**ITEM 8.01 OTHER EVENTS**

On December 18, 2013, Cash America International, Inc. (the “Company”) issued a press release announcing that it has completed the acquisition of substantially all of the assets of PawnMart, Inc., which operates 34 pawn-lending locations in the States of Georgia and North Carolina primarily under the name PawnMart. The aggregate purchase consideration for this acquisition was approximately \$61 million. The full amount of the consideration was paid in cash and funded through borrowings under the Company’s line of credit.
