Once exercisable, the SARS would entitle the Reporting Person to receive the cash value of the options in lieu of exercising the options.

(2) The stock options become exercisable with respect to one-fourth of the underlying shares of Common Stock on each of April 12, 2017, April 12, 2018, April 12, 2019 and April 12, 2020.
