**Dankner Investments Sale of Matav Shares to Delek Assets and Investments Is Not Concluded**

**NETANYA, Israel, January 1, 2004** Matav-Cable Systems Media Ltd. (Nasdaq: MATV), a leading Israeli provider of digital cable television services, today announced that in regard to its press release dated November 3, 2003, concerning its parent company, Dankner Investments Ltd. ( Dankner ), Dankner reported today that the non-binding memorandum of understanding with Delek Assets and Investments ( Delek ) has expired on December 31, 2003, without the parties reaching a binding agreement.

Dankner also reported that the parties are considering continuing their negotiations on different principles.

**Matav is one of Israel's three cable television providers, serving roughly 25 percent of the population. Matav's investments include 5.3 percent of Partner Communications Ltd., a GSM mobile phone company and 10 percent of Barak I.T.C. (1995), one of the three international telephony providers in Israel.**
