TOWER SEMICONDUCTOR LTD.

6,072,779 Ordinary Shares

Pursuant to this prospectus supplement, the accompanying Prospectus Supplement No. 4 and the accompanying base prospectus, we are offering 5,940,014 ordinary shares to YA Global Master SPV Ltd., or YA Global for a total consideration of \$8 million, pursuant to an advance made to us by YA Global under our previously announced Standby Equity Purchase Agreement, or SEPA, dated August 11, 2009 as amended to date. This prospectus supplement also covers the issuance of 132,765 shares to YA Global in payment of \$187,500 of the commitment fee payable to YA Global under the SEPA. We expect to issue the shares to YA Global against payment therefor and in satisfaction of the commitment fee on or about December 29, 2010.

In addition to our issuance of ordinary shares to YA Global pursuant to the SEPA, this prospectus supplement, the accompanying Prospectus Supplement No. 1 and the accompanying base prospectus also cover the resale of those shares by YA Global to the public. YA Global may be deemed to be an “underwriter” within the meaning of the Securities Act of 1933, as amended.

Our ordinary shares are quoted on the NASDAQ Global Market and the Tel-Aviv Stock Exchange under the symbol “TSEM.” On December 27, 2010, the last reported sales price of our ordinary shares on the Tel-Aviv Stock Exchange was NIS 492.9 per share. On December 24, 2010 the last reported sale price for our ordinary shares on the NASDAQ Global Market was \$1.36 per share.

The shares are being issued as part of the commitment by YA Global to purchase from time to time, at our option, our ordinary shares pursuant to the SEPA. After giving effect to the issuance of the shares and payment therefor as described in this prospectus supplement, a maximum of \$27 million is available for future advances under the SEPA.
