- (1) Grant date, 15% vests every six months for the first 12 months, 6.25% vests quarterly for the following 24 months and 5% vests quarterly for the remaining 12 months.
- (2) Grant date, 25% vests after 6 months and in 10 equal quarterly installments thereafter. The vesting of the unvested options priced at higher than \$25.00 vested on December 25, 2005.
- (3) Grant date, 100% vests on December 31, 2005.
Includes 44,945 time-based and performance-based (now deemed earned). 16,515 shares vest in Quarter 1 of 2010, 12,930 shares vest in Quarter 1 of 2011, and 7,500 shares vest in Quarter 1 of 2012. - (6) Grant date; These are performance-shares awards with market conditions tied to company stock price to be earned over a two year period. If earned, the shares will vest over a three year period beginning February 8, 2010.
