Total common shares of 136,082 represents 133,381 common shares held by SRFIX, 2,652 common shares held by SRIX AFF and 49 common shares held by SRBIX. Dow is a managing member of SRB Associates IX L.L.C., the general partner of SRBIX, the general partner of SRFIX and SRIX AFF. Dow disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
