- (1) Each restricted stock unit represents a contingent right to receive the Fair Market Value of one share of common stock, payable only in shares of common stock.  
The Restricted Stock Units vest in increments as follows: (a) Upon the Company achieving at least \$ 2.00 of cumulative earnings per share for any consecutive four financial quarters from 4/1/2011 through 9/30/2013 (the "EPS Performance Measure"), 2,920 Restricted Stock Units shall vest on the close of the business day immediately following the release of earnings for the quarter in which the EPS Performance Measure is met ("EPS Vesting Date") and 1,460 Restricted Stock Units shall vest on the first anniversary of the EPS Vesting Date and 1,460 Restricted Stock Units shall vest on the second anniversary date of the EPS Vesting Date;
- (2) (b) Upon the Company's stock price closing at or above \$30.00 per share for 30 consecutive trading days provided such 30th trading day is prior to 9/30/2013, 1,460 Restricted Stock Units shall vest on the close of the business day when such trading threshold is satisfied, 730 Restricted Stock Units shall vest on the first anniversary of the satisfaction of such threshold and 730 Restricted Stock Units shall vest on the second anniversary of the satisfaction of such threshold; (c) Upon the Company's stock price closing at or above \$35.00 per share for 30 consecutive trading days provided such 30th trading day is prior to 9/30/2013, 1,460 Restricted Stock Units shall vest on the close of the business day on which such trading threshold is satisfied, 730 Restricted Stock Units shall vest on the first anniversary of the satisfaction of such threshold and 730 Restricted Stock Units shall vest on the second anniversary of the satisfaction of such threshold.
- (3) Subject to graduated vesting as described in footnote (2),(3) and Section II.A.(1) of the Restricted Stock Unit Agreement dated February 24, 2011.
