- (1) Effective December 3, 2012, the Compensation Committee of the Board of Directors of United Natural Foods, Inc. (the "Company") granted an award of 25,000 performance shares to the reporting person. The vesting of these performance shares are subject to the Company' attainment of certain levels of operating income and return on invested capital for the performance period from October 28, 2012 through August 3, 2013. The actual number of performance shares that vest can range from 0% to 200% of the 25,000 granted.
