- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU grated at that time represented a contingent right to receive one share of CUB stock.
- (2) Shares withheld by CUB to satisfy the minimum statutory tax withholding obligations that arose upon the vesting of the RSUs.  
 This is the second of 4 vesting installments of RSUs granted to the Reporting Person on July 17, 2017. The remaining 1084 shares from such grant shall vest in 2 equal installments on October 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.
- (4) This is the first of 4 vesting installments of RSUs granted to the Reporting Person on November 27, 2017. The remaining 3054 shares from such grant shall vest in 3 equal installments on October 1, 2019, 2020 and 2021, subject to the Reporting Person's continuous service through each application vesting date.
