Robinson Trust with shared voting and investment power with respect to the shares owned by the Trust and, accordingly, the Reporting Person has included all such shares in his Section 16

(1) reports. The Maurice R. Robinson Trust, upon the determination of the single trustee who is not a trust beneficiary, distributed an aggregate of 500,000 shares of Common Stock. The Reporting Person received 100,000 shares in the distribution, resulting in a change in form of beneficial ownership of such 100,000 shares from indirect to direct and the disposition of the 400,000 shares distributed to other beneficiaries.
