(2) dividends are paid on HP common stock. The number of derivative securities in column 9 includes 226.3202 vested dividend equivalent rights at \$23.86 per RSU credited to the reporting person's account on 10/05/11, and a de minimus adjustment of 0.9005 due to fractional rounding of the dividend equivalent rights.

(3) As previously reported, on 04/25/11 the reporting person was granted 6,786 restricted stock units ("RSUs"), all of which will cliff vest on 04/25/12. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 34.1291 dividend equivalent rights being reported reflect 34.1291 dividend equivalent rights at \$23.86 per RSU credited to the reporting person's account on 10/05/11.
