- (2) Phantom Shares are convertible into Common Shares on a 1 for 1 basis.
- (3) On June 22, 2005, the Reporting Person's deferred compensation account was credited with Phantom Shares equal in value to the ordinary dividend paid on the underlying WTM Common Shares on the dividend date.

The Phantom Shares are payable, at the election of the Company, in cash or in Common Shares following termination of the Reporting Person's employment with the Company or beginning at an earlier date selected by the Reporting Person in accordance with the terms of the deferred compensation plan.
- (4) Dividends are automatically invested in Phantom Shares at the fair market price per share of the underlying WTM Common Shares on June 22, 2005, the date the dividends are deemed to be paid.
