The shares are subject to forfeiture upon termination of employment prior to the time the restrictions lapse or if the performance restrictions are not met on or before August 15, 2009.
 - (2) Direct ownership includes an aggregate of 9,747 shares of restricted stock subject to performance-based restrictions, including the shares reported in this transaction.
