  - (1) On October 26, 2004, Mr. Stougaard was granted an aggregate amount of 92,105 restricted stock units, subject to the satisfaction of vesting requirements over a five-year period. Upon vesting, Sunstone Hotel Investors, Inc. will deliver one share of Common Stock for each vested restricted stock unit. Mr. Stougaard has only the rights of an unsecured creditor in the restricted stock units and no rights as a stockholder if Sunstone Hotel Investors, Inc. until the restricted stock units vest.
  - (2) On October 26, 2006, 13,815 restricted stock units vested and 4,939 shares of Common Stock were withheld to satisfy tax withholding obligations. The closing share price on October 26, 2006 of Sunstone Hotel Investors, Inc. on the New York Stock Exchange was \$28.94.
