- (2) Pursuant to the Plan the Reporting Person was granted stock appreciation rights with respect to 30,000 shares. 1/4th of such shares will vest on May 14, 2010 and on each one year anniversary thereafter. The 9,000 shares were sold through separate trades, with the sale prices ranging from \$7.47 to \$7.50, and at a weighted average sale price of \$7.4875. The Reporting Person undertakes to provide upon request by the staff of the Securities and Exchange Commission, the issuer, or a security holder of the issuer, full information regarding the number of shares sold at each separate sale price.
