- (1) On 02/23/2010, the reporting person was granted an option to purchase 107,267 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 02/23/2011) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.
- As a result of the sale of shares by the Sponsors, the performance criteria was met with respect to 2,188 shares of common stock subject to this option award, resulting in vesting of the option as to 437 shares and an additional 1,751 shares that are eligible to vest in four equal
- (2) annual installments beginning on 02/23/2012. In total, following this event, the performance criteria has been met with respect to an aggregate of 30,614 shares of common stock subject to this option award, with 6,123 of such shares vested and the remaining 24,491 of such shares eligible to vest in four equal annual installments beginning on 02/23/2012.
