- (1) The sales reported on This Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on 11/4/2011. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$28.78 to \$29.45, inclusive. The reporting person undertakes to provide Dunkin' Brands Group, Inc., any security holder of Dunkin' Brands Group, Inc., or the staff of the Securities Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range set forth in footnote (2) to this Form 4.
- (2) On 2/23/2010, the reporting person was granted an option to purchase 1,915,499 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 2/23/2010) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P.) criteria. As of the date of this filing, the performance criteria has been met with respect to an aggregate of 546,683 shares of Common Stock subject to this option award, with 328,048 of such shares vested and the remaining 218,635 of such shares eligible to vest in two equal annual installments beginning on 2/23/2013.
