 - (1) On 03/09/2011, the reporting person was granted an option to purchase 168,563 shares of Common Stock. The option vests based upon time (five equal annual installments that begin on 03/09/2012) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.
 - (2) As a result of the sale of shares by the Sponsors on 04/04/2012, the performance criteria was met with respect to 53,889 shares of common stock subject to this option award, resulting in vesting of the option as to 10,778 shares and an additional 43,111 shares of common stock that are eligible to vest in four equal annual installments beginning on 03/09/2013. In total, following this event, the performance criteria has been met with respect to an aggregate of 102,003 shares of common stock subject to this option award, with 20,386 of such shares vested and the remaining 81,617 of such shares eligible to vest in four equal annual installments beginning on 03/09/2013.
 - (3) In accordance with applicable rules, the number of Derivative Securities Beneficially Owned Following Reported Transactions reflects only the shares issuable upon exercise of the reported option award and does not include shares of common stock issuable upon the exercise of other option awards that have been previously reported.
