- Between February 22, 2012 and August 22, 2012, the Reporting Person acquired 70.456 shares under Cott's 401(k) plan (based on a plan statement dated as of August 22, 2012). The disposition made on August 23, 2012 was triggered by a loan against Reporting Person's
- (1) 401(k) account. Assets in the account include Cott shares and cash equivalents held in a unitized stock fund in which the participant holds units of stock rather than shares. The loan was funded entirely by the disposition of cash equivalents held in the fund, and not by the sale of Cott shares into the open market.
  - (2) Pursuant to an election made by the Reporting Person during an open trading window, such shares were withheld to satisfy tax withholding obligations due upon the vesting of time-based restricted share units granted to the Reporting Person on August 6, 2010.
  - (3) Between August 23, 2012 and December 28, 2012, the Reporting Person acquired 73.151 shares under Cott's 401(k) plan (based on a plan statement dated as of December 28, 2012).
