- (1) Represents time-based restricted share units (RSUs), which are contingent rights to receive common shares. RSUs that have not been forfeited shall vest on the last day of Cott's 2017 fiscal year.
- (2) On May 4, 2015, the Human Resources and Compensation Committee of the Board of Directors of Cott approved the grant of this award, with a price based on the closing price on the NYSE on May 8, 2015. Such grant was effective on May 26, 2015 upon Mr. Kitching's acceptance of a new employment offer letter with Cott (as described in the Form 8-K filed with the SEC on May 26, 2015).
- (3) Represents an option to purchase 85,421 common shares of Cott. The option cliff vests on the last day of Cott's 2017 fiscal year.
