Unilever NV also announces that 219,705 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 64,266,243 Unilever NV ordinary shares in treasury, and has 1,650,461,457 Unilever NV ordinary shares in issue (excluding treasury shares).
