Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

- (a) On April 27, 2005, Xcyte Therapies, Inc. (the Company) borrowed \$562,000 under its current equipment financing arrangement (the Credit Facility) with Oxford Financial Corporation, resulting in the execution of a promissory note as of that date. This was the third amount borrowed under the Credit Facility, which is governed by a Master Security Agreement dated July 1, 2003 (the Agreement). The promissory note bears interest at a rate of 8.95% per annum, and is to be repaid in 42 equal monthly installments of principal and interest. The promissory note is collateralized by the related equipment acquired under the Credit Facility.

Under this Credit Facility, the Company can borrow up to \$3.0 million. As of the date of the filing of this Current Report on Form 8-K, the Company had \$1.6 million available to it under this Credit Facility, which expires in December 2005.
