Item 1.01 Entry into a Material Definitive Agreement

On October 30, 2006, the Compensation Committee of our Board of Directors approved salary increases for Edward F. Brennan, Ph.D., our President and Chief Executive Officer and Gregory J. Tibbitts, our Vice President, Finance and Chief Financial Officer. Effective November 1, 2006, Dr. Brennan's annual base salary will be increased from \$250,000 to \$325,000 and Mr. Tibbitts' annual base salary will be increased from \$190,000 to \$240,000.
