Item 5.03. Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.

On and effective December 13, 2007, the Board of Directors of BJS Wholesale Club, Inc. approved the following amendments to the company's By-laws:

Section 2.6 (Action by Vote) was amended to provide that in an uncontested election of directors, a nominee will be elected if the votes cast for such nominee exceed the votes cast against such nominee. In the case of a contested election, directors shall continue to be elected by a plurality of the votes cast.

Section 7 (Capital Stock) and Section 8 (Transfer of Shares of Stock) were amended to more explicitly address uncertificated shares. The full text of the amendments is included in the exhibit filed herewith and is incorporated herein by reference.
