QVT Financial LP (QVT Financial) is the investment manager for the several funds (the Funds), which beneficially own an aggregate amount of 7,697,559 shares of Common Stock, consisting of 676,543 shares of Common Stock owned by Quintessence Fund L.P. (Quintessence), 1,274,228 shares owned by QVT Associates LP, 3,343,841 shares owned by QVT Overseas Ltd. and 1,592,853 shares owned by QVT Global II L.P. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which holds 810,094 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each of the Funds and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 7,697,559 shares of Common Stock, consisting of the shares owned by the Funds and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of Quintessence, QVT Associates LP and QVT Global II L.P., may be deemed to beneficially own the aggregate number of shares of Common Stock owned by Quintessence, QVT Associates LP and QVT Global II L.P. and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 3,543,624 shares of Common Stock.

Each of QVT Financial and QVT Financial GP LLC disclaims beneficial ownership of the shares of Common Stock owned by the Funds and held in the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by Quintessence, QVT Associates LP and QVT Global II L.P. except to the extent of its pecuniary interest therein.

The reported share amounts reflect amounts beneficially owned by the reporting persons as of December 31, 2007, as adjusted for subsequent transactions through the date hereof.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 70,133,499 shares of Common Stock outstanding, which is the total number of shares issued and outstanding reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2007 and filed with the Securities and Exchange Commission on November 9, 2007.
