ChipMOS REPORTS JANUARY 2008 REVENUE

Hsinchu, Taiwan, February 20, 2008 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of January 2008.

Revenue for the month of January 2008 was NT\$1,680.2 million or US\$52.2 million, a decrease of 11.3% from the month of December 2007 and a decrease of 15.8% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.17 against US\$1.00 as of January 31, 2008.)
