On April 23, 2009, the Board of Directors adopted amendments effective May 31, 2009, to the Media General, Inc., Executive Supplemental Retirement Plan (SERP) and the Media General, Inc., ERISA Excess Benefit Plan (ERISA Excess Plan). Under these amendments, compensation earned after May 31, 2009, does not increase accrued benefits for participants under the plans. The Company expects to record a modest curtailment gain in the second quarter of 2009 as a result of these retirement plan amendments.
