ITEM 3.02 UNREGISTERED SALES OF EQUITY SECURITIES

On December 30, 2009, the Company entered into an agreement to exchange (the Exchange) \$40,000,000 in principal amount of 5.50% Subordinated Notes due 2015 (the 5.50% Notes) for \$40,000,000 in principal amount of 2009 5.50% Subordinated Notes due 2015 (the 2009 5.50% Notes) held by Jackson National Life Insurance Company (Jackson) pursuant to the Exchange Agreement, dated as of December 30, 2009, between the Company and Jackson. Each \$1,000 in principal amount of the 5.50% Notes are convertible into, at the option of the holder, either 40 depository shares each representing a 1/40th ownership interest in a share of the Company's Series A Floating-Rate Non-Cumulative Perpetual Preferred Stock (the Series A Preferred Stock) or 40 depository shares each representing a 1/40th ownership interest in a share of the Company's 9.50% Series C Non-Cumulative Perpetual Preferred Stock (the Series C Preferred Stock). The 2009 5.50% Notes do not contain this conversion feature. The 5.50% Notes are otherwise identical to the 2009 5.50% Notes. The Exchange Agreement is filed as Exhibit 99.1 and is incorporated herein by reference. The description of the terms of the Exchange is qualified in its entirety by reference to the Exchange Agreement.

The Exchange was conducted in reliance on Section 3(a)(9) of the Securities Act of 1933, as amended (the Securities Act). No commission or other remuneration was paid or given directly or indirectly in connection with the Exchange. As a result, the Exchange was exempt from the registration requirements of the Securities Act. Any depository shares issued upon conversion, whether representing the Series A Preferred Stock or the Series C Preferred Stock, up to a total of 1,600,000 depository shares representing either the Series A Preferred Stock, the Series C Preferred Stock, or some combination thereof, will be issued in reliance on the exemption provided in Section 3(a)(9) of the Securities Act.

Settlement is expected to occur in January 2010.
