**Appeal of Imposition of a Fine**

**Details:**

On February 23, 2011(Local Date), LG Display filed with the European Union General Court an application for partial annulment and reduction of the fine imposed by the European Commission ( EC ) on December 8, 2010. The EC had imposed a fine of EUR 215 million on LG Display for a violation of the European Union competition law.
