**Item 8.01. Other Events.**

On May 5, 2011, Host Hotels & Resorts, Inc. ( Host Inc. ) issued a press release announcing that Host Hotels & Resorts, L.P. ( Host L.P. ), for whom Host Inc. acts as general partner, priced its private placement offering (the Offering ) of \$425 million aggregate principal amount of ~~7~~<sup>8</sup>% senior notes due 2019. The net proceeds of the Offering of approximately \$415 million, after taking into account discounts, fees and offering expenses, will be used to redeem all of Host L.P.'s \$250 million aggregate principal amount of outstanding <sup>7</sup>/<sub>8</sub>% Series K senior notes due November of 2013, to repay \$50 million in borrowings under Host L.P.'s credit facility and for general corporate purposes. A copy of the press release is attached hereto and is incorporated by reference herein.
