This voluntary delisting from The NASDAQ Capital Market (NASDAQ) of the Issuer s common stock under the trading symbol NANX is a result of the Issuer s receipt on September 16, 2011 of notice from NASDAQ indicating that the Issuer was no longer in compliance with NASDAQ Rule 5550(a)(2) requiring a \$1 minimum bid price and the Issuer s ensuing determination that it would not be able to regain compliance with such continued listing requirement in a timely fashion.
