This Amendment No. 10 (the "Amendment") amends and supplements the Schedule 13D (the "Original Schedule 13D") filed with the Securities and Exchange Commission (the "SEC") on November 9, 2009 by the Reporting Persons, as previously amended. This Amendment, and the Original Schedule 13D, relate to the shares of Common Stock, par value \$0.001 per share ("Common Stock") of Dole Food Company, Inc., a Delaware corporation (the "Issuer"). The principal executive offices of the Issuer are located at One Dole Drive, Westlake Village, California 91362. Capitalized terms used but not otherwise defined in this Amendment have the meanings ascribed to such terms in the Original Schedule 13D. Except as amended and supplemented by this Amendment, the Original Schedule 13D, as previously amended, is not amended or supplemented in any respect.

Item 5. Interest in Securities of the Issuer

The Response to Item 5 of the original Schedule 13D, as previously amended, is hereby amended to supplement parts (a) and (b) of Item 5 with the text below and to add Schedule A.

(a) and (b)

Interests of Reporting Persons and Others:

Mr. Murdock: As of the date of this amendment, Mr. Murdock has beneficial ownership of an aggregate of 56,674,244 shares of Common Stock, or 63.7% of the Common Stock. Of these 56,674,244 shares of Common Stock, Mr. Murdock has (a) sole voting and sole dispositive power with respect to 56,674,244 shares of Common Stock and shares voting rights with respect to 0 shares of Common Stock. Of these 56,674,244 shares of Common Stock, (a) 44,889,330 are owned directly by Mr. Murdock, as Trustee of the David H. Murdock Living Trust and (b) 11,784,914 are owned directly by Holdings. Mr. Murdock has beneficial ownership of the shares owned directly by Holdings.

(c) The transactions in the Common Stock listed on Schedule A to this Amendment were effected by the Reporting Persons, all as purchases by the David H. Murdock Living Trust in the open market on the New York Stock Exchange, pursuant to a previously adopted 10b5-1 plan.
