Julie A. Scott Rose beneficially owns 983,436 shares of Common Stock (of which 980,540 shares are Class B Common Stock and 2,896 shares are Class A Common Stock), representing 5.3% of the Class A Common Stock and 3.8% of the Class B Common Stock.

Ms. Rose has sole voting and dispositive power for 983,436 shares of Common Stock, which includes 877,186 shares of Class B Common Stock held as trustee of the Julie Scott Rose Revocable Trust, 74,834 shares of Class B Common Stock held by three separate trusts, of which Ms. Rose is the trustee of each trust, 27,892 shares of Common Stock underlying stock options that are currently exercisable or exercisable within 60 days of the date hereof (of which 25,920 are Class B and 1,972 are Class A), and 3,524 shares held individually (of which 2,600 are Class B and 924 are Class A).
