On May 9, 2013, Orthofix International N.V. (the <u>Company</u>), through its subsidiary Orthofix Inc. (the <u>Subsidiary</u>, and collectively with the Company, <u>Orthofix</u>) entered into a letter agreement with Vicente Trelles, Orthofix s Executive Vice President of Worldwide Operations and Shared Services, pursuant to which it was mutually agreed that Mr. Trelles employment with Orthofix would cease as of the close of business on May 10, 2013 (the <u>Letter Agreement</u>). Pursuant to the Letter Agreement, Mr. Trelles will be entitled to receive, subject to the terms and conditions set forth therein, approximately \$479,000 in severance benefits and legal expense reimbursements from the Subsidiary. Mr. Trelles will also receive certain paid health and dental benefits from the Subsidiary for up to 18 months. The foregoing summary does not constitute a complete summary of the terms of the Letter Agreement, and is qualified in its entirety by reference to the text of such Letter Agreement, which is filed herewith as Exhibits 10.1, and is incorporated herein by reference.
