On August 12, 2013, Navios Maritime Acquisition Corporation (Navios Acquisition) entered into the Seventh Supplemental Indenture in order to add the entities identified in such Seventh Supplemental Indenture as guarantors to its Indenture dated October 21, 2010. A copy of the Seventh Supplemental Indenture is attached hereto as Exhibit 10.1 to this report on Form 6-K (this Report) and is incorporated herein by reference.

On August 13, 2013, Navios Acquisition issued a press release announcing the acquisition and delivery of the Nave Celeste, a 298,717 dwt VLCC. The Nave Celeste will be assuming the existing charter of the Shinyo Navigator, a 1996-built VLCC, with a remaining period of 3.3 years (the Substitution). As a result of the Substitution, the Nave Celeste and related securities will replace the Shinyo Navigator as certain collateral securing Navios Acquisition s 8¹/₈% First Priority Ship Mortgage Notes due 2017. A copy of the press release is furnished as Exhibit 99.1 to this Report and is incorporated herein by reference.

This Report is hereby incorporated by reference into Navios Acquisition s Registration Statements on Form F-3, File Nos. 333-169320 and 333-170896.
