This Registration Statement on Form S-8 is filed by the Registrant to register an additional 9,000,000 shares of common stock, par value \$0.01 per share (the Common Stock ), of Celgene Corporation (the Registrant or the Corporation ), which may be awarded under the Celgene Corporation 2008 Stock Incentive Plan (Amended and Restated as of April 17, 2013) (the Plan ) pursuant to an amendment of the Plan approved by the Corporation s Board of Directors on April 17, 2013, effective and approved by the stockholders of the Registrant on June 12, 2013.
