4,389,654 shares including 2,800 shares owned by Ms. Shreve jointly with her husband; 1,175,000 shares owned by Shadow Holdings, LLC, an LLC whose sole members are Barbara Bainum and trusts for her benefit, for which Ms. Shreve is manager and has shared voting authority; 1,685,061 shares owned by Posadas Holdings, LLC, for which Ms. Shreve is Manager and has shared voting authority, and whose sole members are Bruce Bainum and various trusts for either his benefit or the benefit of his wife or children; 1,520,625 shares owned by Sweetwater Holdings, LLC, for which Ms. Shreve is Manager and has shared voting authority, and whose sole members are Roberta Bainum and trusts for either her benefit or the benefit of her children; and 6,168 shares owned by trusts for the benefit of Renschler family members for which Ms. Shreve is the trustee.
