Calithera Biosciences, Inc. (the **Registrant**) is filing this Registration Statement on Form S-8 for the purpose of registering an additional (a) 729,265 shares of its common stock, par value \$0.0001 per share (the **Common Stock**), issuable to eligible persons under the 2014 Equity Incentive Plan, which Common Stock is in addition to the shares of Common Stock registered on the Registrant's Form S-8 filed on May 11, 2015 (File No. 333-204056) and on October 2, 2014 (File No. 333-199126) (the **Prior Forms S-8**) and (b) 182,316 shares of Common Stock issuable to eligible persons under the 2014 Employee Stock Purchase Plan, which Common Stock is in addition to the shares of Common Stock registered on the Prior Forms S-8.
