On March 22, 2016, Terri L. Herrington, Vice President, Finance, and Controller, notified International Paper Company (the Company) that she plans to retire on December 31, 2016.

Vincent P. Bonnot has been appointed Vice President, Finance, and Controller, effective July 1, 2016. Mr. Bonnot, age 45, currently serves as Chief Financial Officer, International Paper Europe, Middle East and Africa ( IP EMEA ), a position he has held since November 2013. He previously served as Finance Director for the IP EMEA packaging business from June 2010 to November 2013, and as Director of Strategic Planning for IP EMEA from September 2008 (when he joined the Company) to June 2010.

There have been no transactions since the beginning of the Company's last fiscal year, and there are no currently proposed transactions, in which the Company was or is to be a participant and in which Mr. Bonnot (or any member of his immediate family) had or will have any interest, that are required to be reported under Item 404(a) of Regulation S-K. The appointment of Mr. Bonnot was not pursuant to any arrangement or understanding between him and any person, other than a director or executive officer of the Company acting in his or her official capacity.
