- (1) The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person in March 2005. Represents 1,968 shares acquired under NVIDIA's 1998 Employee Stock Purchase Plan (Section 423) in February 2005 were previously reported as having been held directly by the Reporting Person. These shares were subsequently transferred into the Shannon Revocable Trust (the "Trust") and are now owned by the Reporting Person indirectly through the Trust with voting and dispositive power. This transfer did not constitute a change in beneficial ownership.
- (2) An option to purchase 250,000 shares at an exercise price of \$11.07 was granted on July 26, 2002. The options vests over a four year period with 25% vesting on July 26, 2003, and the remainder vesting quarterly in equal installments.
