## Explanation of Responses:

- (1) The number of underlying securities is based on the stock fund balance on July 29, 2011. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on an July 29, 2011, stock fund price of \$36.95 per share.
- (2) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock.
- (3) Phantom stock units representing dividends which relate to vested deferred awards are payable in cash following the reporting person's retirement from the issuer and may be transferred into an alternative investment account. Vesting continues when the reporting person retires from the issuer.
- (4) The phantom stock units were awarded pursuant to and accrued under the Johnson Controls Executive Deferred Compensation Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company, subject to vesting provisions.
- (5) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (6) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
