- (1) 389 previously owned shares having a market value of \$17.73 per share were delivered in payment of the option price of \$5.52 per share for 1,250 shares acquired pursuant to the exercise of an option granted under the 2002 Plan.
1,250 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. The option purchase price was paid in accordance with the 2002 Plan in the form of 389 shares valued in accordance with the 2002 Plan. In addition, 278 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.
- (2) 1,958 previously owned shares having a market value of \$17.73 per share were delivered in payment of the option price of \$6.81 per share for 5,100 shares acquired pursuant to the exercise of an option granted under the 2002 Plan.
5,100 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. The option purchase price was paid in accordance with the 2002 Plan in the form of 1,958 shares valued in accordance with the 2002 Plan. In addition, 1,012 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant. As a result of the transactions reported herein, the reporting person's direct ownership of common shares increased by 2,713 shares.
