(1) No transaction is being reported on this line. Reported on a previously filed Form 4. On December 20, 2005, the reporting person filed a Form 4 to report a grant of options that occurred on December 16, 2005. Due to an inadvertent clerical error the number of shares reported in Columns 5, 7 and 9 on Table II was incorrect.
