The 12.742 phantom units represent half of the \$1,000 fee paid for his participation in the March 28, 2006 meeting of the Employee Benefit Plans Committee for which he is a member. The remaining 50% was put into a deferred cash account.
- (2) In addition to the phantom stock units accrued in Mr. Policano's deferred compensation account, he also owns 7,500 shares of Badger Meter, Inc. common stock.
