Martin Resource Management Corporation (1) indirectly owns 1,311,643 common units and 3,402,690 subordinated units of the Issuer through three of its wholly-owned subsidiaries (Martin Product Sales LLC, Midstream Fuel Service LLC and Martin Resource LLC). As a result, Ruben S. Martin may be deemed the beneficial owner of the common units and subordinated units owned by Martin Resource Management Corporation.
