(1) Each share of class B common stock, par value \$0.01, of the issuer (the "Class B Common Stock") is convertible at any time, at the option of the holder, into one share of class A common stock, par value \$0.01, of the issuer (the "Class A Common Stock").

(3) On December 15, 2005, the reporting person was granted 120,000 shares of restricted Class B Common Stock. The restricted Class B Common Stock vests upon certain liquidity events if certain performance criteria are met. In connection with the issuer's secondary public offering, on May 31, 2007, 2,790 shares of restricted Class B Common Stock vested due to the exercise of an over-allotment option by the underwriters of the offering.
