- (2) The option vests as follows: 20,000 shares at date of grant; 12,000 shares in the first quarter of year 2 and 8,000 shares in the second quarter of year 2; and 12,000 shares in the first quarter of year 3 and 8,000 shares in the second quarter of year 3.
